## INTRODUCTION

***This document is intended for use by those involved in running the Target Rifle Australia Ltd. National Championships. While some of the information contained in these notes may seem unnecessary, it is mainly for the benefit of those individuals who have not previously been involved in the organization and running of a National Championship Event.***

The document contains items that are included to provide guidance, items that are mandatory.

### **Mandatory items are indicated in ‘*bold italics*’.**

***The requirements of Target Rifle Australia Limited, with respect to the conduct of the Australian National Championships, shall be binding on the state, which has agreed to conduct the competition.***

***When adopted, this document supersedes all previous documents, including by-laws.***

***This document is effective from 1<sup>st</sup> January, 2018 and is to be reviewed annually.***

Any questions regarding the contents of this document or the organisation of the National Championships should be directed to the TRA Competitions Committee via the TRA Executive Officer.

## 1. EVENT PLANNING

At the very beginning of planning for this event, it is anticipated that each host state would form a Nationals Organising Committee consisting of a number of people, including an independent representative of TRA Ltd. **This committee should consist of some experienced members (if possible) and also some newcomers to ensure a passing on of knowledge and experience. The organisation and conducting of this event should not be left to just one or two people.**

Remember, this is a National Championships not a local prize meeting or even a State Championships, therefore, some aspects of the organization and execution of the event may be different to that in your own club or state association.

At the very beginning of planning, it is beneficial for the organising committee to compile a detailed **check list** of anything & everything that is needed and needs to be done in preparation for the event and in order of priority. An excel spreadsheet is an easy format for such a list. With required tasks assigned to particular members, this list is an easy way of tracking planning progress and ensuring all tasks are completed in time for the event.

Please use the information following in this document and the additional forms to assist in the planning and conduct of the event. Also, feel free to contact the appointed Technical Delegate and Competitions Committee for further information and assistance. To avoid confusion, it is best that this liaison is left to just one person, perhaps the Chairman of the Organising Committee. It is essential that all members of the committee are kept up to date with any decisions and changes made.

As the National Championships are held on a different range and in a different state each year, it is impossible for the TRA Competitions Committee/TRA Board to set a programme to suit each state - local knowledge and input is essential.

While it is preferable that the Nationals are held on a rotational basis between the states, occasionally, circumstances may prevent a particular state from conducting the event in their 'rotational' year. In this instance, The Board will call for an expression of interest from other states to conduct the event.

This expression of interest does not involve any extra costs payable to TRA but merely a question "this state cannot hold the event in this particular year, would another state like to conduct the event in their place?"

Although it is of great benefit to shooters and officials, no state association is compelled to conduct the Nationals just because it is their rotational turn. Availability of facilities, facility costs and availability of adequate personnel can be deciding factors in this decision.

It is preferable that any one state does not conduct the event two years in a row.

## 2. THE RANGE

### 2.1 Standards

The standard of the range is the most important consideration when conducting a successful National Championship. The following are some important factors to consider.

### 2.2 Size

- a) The recommended minimum number of firing points for 50m Ranges is 30.
- b) The recommended minimum number of firing points for 10m Air Rifle is 20.
- c) It is preferred that all ranges are in close proximity to each other for the convenience of competitors.

### 2.3 Shooting Bays

***The shooting bays should conform as closely as possible to the standards set down in the current ISSF regulations.***

### 2.4 Spectator Areas

It is desirable that spectators should be able to enter the range to watch the shooting without disturbing the competitors.

### 2.5 Preparation

If a new range is being constructed, it would be desirable that some liaison take place with members of the Technical Committee to ensure high range standards and compliance.

## 3. FACILITIES

### 3.1 Toilets

- a) It is imperative that the range has ample toilet facilities kept to an acceptable standard of cleanliness.
- b) ***Facilities for disabled shooters must also be available.***

### 3.2 Parking

- a) There should be adequate parking and a set down area for the convenience of all competitors.
- a) ***Parking for disabled shooters must be provided and be as close as possible to the entrance of the range.***

### 3.3 Offices

A reception point should be set-aside for shooters to check in on arrival and for all general enquiries. If possible, it should be manned at all times during the competition.

### 3.4 Equipment area

- a) The range should have an area close to the firing point where competitors can assemble their equipment.
- b) There should be enough room for at least two squads and preferably all the competitors. This is an absolute necessity in case of inclement weather.

### 3.5 Equipment checks

***Equipment control and equipment checks are to be made available for those shooters who wish to have their equipment tested. Ensure that an area with plenty of room is available for this purpose where no events or training are being held.***

- a) ***Random checks may be carried out.***
- b) ***The ISSF dress regulations shall not be rigidly enforced for the National Championships provided that the competitor gains no unfair advantage.***
- c) ***Equipment control sheets are available from the Technical Delegate.***

### 3.6 Scoring Area

- a) There must be a room large enough and with adequate lighting for the scorers and RTS (Results, Timing & Scores) staff to work unhindered and away from competitors.
- b) Items of equipment that may be necessary will include calculators (spare batteries), pens, pencils, felt pens, rulers, photocopier, paper, computer/s, printer/s, rule books, masking/sticky tape, scoring machine, gauges, magnifying glasses etc.

### 3.7 Scoreboard/Notice Board/Results Area

- a) The Scoreboard/Notice Board/Results area should be in a prominent place away from the firing point. A position near the canteen will add to the turnover at the canteen.
- b) It is advisable that, when a computer has been used to list results, the print be as large as possible to be read by all.

### 3.8 Catering Area

- a) There should be an area on the range where snacks can be prepared. It is an advantage to have an adjacent area to consume the food. This should be sufficiently removed from the firing point to prevent carryover of noise to the competition area.
- b) Decide if lunch and/or dinner are to be provided and whether local club members can handle this or whether a catering firm must be engaged. Catering can bring in a considerable amount of money to a club or state association if handled properly. It may mean a little extra organisation but the profit will be worth it. Most shooters appreciate the more personal approach gained from a club or state handling the catering as opposed to an external caterer.

### 3.9 Flag Poles

- a) ***Only State or Territory flags, as supplied by TRA are to be flown at every National Championships, together with the Australian Flag. If international competitors or teams are competing, their national flags may be flown. (visitors supply)***
- b) ***The TRA flags, which are stored in a special box, should be forwarded from the state which held the previous Nationals. The flags will be passed to a representative of the next host association at the Presentation Dinner or final awards presentations.***

### 3.10 Air Rifle Venues

***Facilities for Air Rifle Competition must meet a minimum standard:***

- a) ***Air Rifle ranges must be indoors.***
- b) ***Must have single aiming targets i.e. Target Returning Machines or fully Electronic Scoring Targets.***
- c) ***Bay width must meet ISSF standards.***
- d) ***Lighting must comply with ISSF rules. For details refer to ISSF General Technical Rules, General Range Standard, Indoor Range Aight Requirements (Lux) 6.4.14***

### 3.11 Armoury

***An area must be set aside for the secure storage of firearms, for the duration of the Championships, in accordance with local Police Licensing Regulations.***

***Access to the armoury must be provided throughout the duration of the competition so that there is no inconvenience to the competitors. Whilst it may be difficult to ensure the armoury is manned at all times, there should be at least one person available, throughout the day, with access to the armoury. A list of those with access to the armoury should be posted on the notice board, in the event the designated armoury person is unavailable.***

### 3.12 General Preparation & Presentation

***It is essential that all range equipment and facilities are in good working order, are clean and tidy and free of hazards to provide a safe and comfortable environment for all competitors and visitors to the championships.***



## 4. COSTING

### 4.1 Entry Fees/Payments

- a) *Payment of entry fees will be by arrangement between TRA & the host state. Details will be included in the entry form.*
- b) *A portion of the entry fee, as determined from time to time by TRA Ltd, will be retained by TRA and listed as part of any agreement.*
- c) *TRA will liaise with the Host State Organising Committee to ensure that all costs incurred to the host state, in the preparation and running of the championships, are covered and that a reasonable profit can be made.*

### 4.2 Budget

To ensure the Championships do not run at a loss a budget needs to be established for the following normal costs:-

- a) Stickers to label paper targets (if used).
- b) *Medals, including Grade Medals are supplied by TRA according to 7:5 Grades and Forms: 7. Award List.*
- c) *The host state shall have a colour computer printer available to assist with the printing of award certificates for postal & teams events.*
- d) *It is recommended that the host state produce a Certificate of Participation for each competitor entered in the National Championships.*
- e) Host states are encouraged to seek sponsorship to cover the cost of any additional trophies etc.
- f) Reasonable sponsor advertising may be displayed but sponsors names are not to be used in the title of the championships. e.g. "The Telstra TRA National Championships". "The TRA National Championships sponsored by Telstra" is acceptable.
- g) Printing of programmes, information and promotional brochures, squadding information, stickers, equipment check forms and stickers, results booklet, postage, recording sheets (air rifle), protest forms, Range Officer's complaint forms etc.
- h) Presentation Dinner (including Public Holiday surcharge if applicable)
- i) Range Facility Hire, including any additional venue costs e.g. SISC/MISC.

## 5. PERSONNEL

Generally, visiting shooters are more than willing to assist with the running of the event though it is preferred that members from the host state fill the majority of the required roles. This is an excellent learning opportunity for inexperienced officials.

### 5.1 Reception Point

The reception point should be manned continually from the day prior to the commencement of competition. The personnel should have all the current squadding details and be very familiar with the overall organisation of the event.

- a) The reception point must not be in the same area as that used for scoring.
- b) Start Lists should be available to the reception personnel for all the matches so that last minute additions and alterations can be made without unduly upsetting the operation of the scoring and classification work.

### 5.2 Technical Delegate

- a) *The technical Delegate for the National Championships will be appointed by the TRA Technical Committee.*

The Technical Delegate is the TRA representative at the Championships and advises on the pre-match organisation, examines the Ranges and other Facilities and the general overseeing of the Organising Committee. ***The TD cannot be a member of the National Championships Organising Committee and should be a qualified range official. The TD cannot actively participate in the National Championships.***

- b) Upon appointment, the Technical Committee will notify the host state of the appointment.***
- c) Expenses for the TD will be as determined by the TRA Board.***
- d) All enquiries and questions regarding the event should be directed to the Technical Committee via the Technical Delegate.***

### 5.3 Juries

***The Technical Delegate is to ratify all Juries (Range, Equipment and RTS) and Jury of Appeal. All Jury members must be suitably qualified.***

- a) Juries shall consist of a Chairman and two to four persons to advise and supervise the staff in scoring procedures, posting of results, equipment checks, range procedure, target distribution and decisions on protests.***
- b) Jury members should be easily identifiable with a red vest when on duty so they can be consulted quickly.***
- c) The Jury of Appeal shall consist of three members (including the Chairman) and is responsible for making the final judgement on all appeals against Jury decisions.***
- d) Members of the Jury of Appeal are generally higher level accredited officials and usually include the Technical Delegate, a high ranking official from the host state and a high ranking official from another state.***

### 5.4 RTS Jury (Results, Timing & Scores)

- a) RTS Jury should check results. The Chairman or a member of the RTS Jury must sign the posted results. i.e. Results Posted (Time) - Protest Time Ends (Time). Protest time is 10 minutes.***
- b) Independent of scoring, the RTS Jury must check the top ten targets (Paper Targets) or printouts of each match before final posting.***
- c) Where EST's are used, the Chairman should have ISSF EST accreditation with all members of the RTS Jury being proficient in EST use.***

### 5.5 Range Officers

- a) The host state must ensure there are adequate range officials (Chief Range Officer/s & Range Officers) available for the safe and efficient running of events. This is especially important when multiple ranges are in use concurrently. A Chief Range Officer must be available for each range and cannot be competing at the same time.***
- b) The Chief Range Officer and assistants should be clearly identifiable by the competitors, with armbands or vests, so that they can be called easily and quickly when needed. The CRO's should have different coloured armbands or vests than the assistant RO's and Jury members.***
- c) The Chief Range Officer should be absolutely consistent in the instructions and for consistency, use Match Command Sheets (ISSF) for all matches. Up to date command sheets are available from the Technical Committee.***
- d) The range officers controlling the competitions should pay careful attention to all instructions given by the Chief Range Officer.***
- e) It is essential that Range Officials have the correct forms (i.e. Range Incident Report Form & Protest Forms) & at least one copy of the latest ISSF & Australian Supplementary Rules available for use.***

## 5.6 RTS Staff (Results, Timing & Scores)

***The Organising Committee is to ratify a Chief RTS Officer, Scorers and RTS Officers throughout the Championships. It is extremely important that all results are scored, posted & recorded correctly. Only results for events & categories contested should be posted. The handling of statistical operations should be organised so that scores are available to the competitors at the very earliest opportunity.***

***It is also important that all equipment needed to carry out these tasks is readily available, this includes: a photocopier, paper, sticky tape, pens, gauges, magnifying glasses, pocket folders, score sheets, suitable lighting, staplers, target scoring machine (& someone who knows how to use it) etc.***

### 5.6.1 Paper Targets

- a) The statistical operations should be considered very early in the planning of the event.
- b) The statistical operations will also control the numbering system required on the targets. If a computerised system is to be used it is essential that the target numbering and the computer system are fully compatible. This should be carefully considered and possibly tested at a prior event.
- a) As the majority of all statistical information is now stored electronically, it is essential that all information is stored in at least 2 places as well as paper copies being kept.
- b) Sufficient number of Scorers, Check Scorers and Statistical Personnel should be rostered so the scores for a squad are determined in about 30 minutes. As a rule of thumb there should be at least one team of scorers (2 scorers & 1 check scorer) for 25 Competitors, 2 Teams for up to 50. For scoring 20m one extra team is desirable.
- c) It is desirable that there should be more than one group of scorers and statisticians available. This gives them time to compete and mix with the other competitors and lessens the probability of errors being made due to tiredness.
- d) The RTS personnel could also be responsible for the preparation of daily medals and awards. To save confusion, it is preferable that this task is only carried out by 1 or 2 people.

### 5.6.2 Electronic Scoring Targets

***Where EST's are to be used, the host state Organising Committee must ensure that at least 2 persons, who are fully conversant with the operation of the target system, are present at all times during competition.***

## 6. THE COMPETITION

### 6.1 Equipment Checks

The Technical Delegate is to ratify equipment control personnel.

### 6.2 Squadding/Start Lists

- a) ***Corrected start lists should be in the hands of the Range Officer at least 20 minutes before the start of the squad. It is imperative to ensure the correct shooter is on the correct firing point and all information on the start list coincides with the scoring room and computer.***
- b) Competitor Bib Numbers, which are to be worn by all competitors during competition, are of benefit with this task.
- c) ***Start lists should be posted on the Official Notice Board at least 16 hours prior to each event. Start Lists could also be posted on websites.***

### 6.3 Targets

#### 6.3.1 Approval

- a) ***Samples of the "paper" targets for all matches must be sent to the Technical Delegate for approval 6 months beforehand.*** That is, that the dimensions are correct, the layout is suitable, the material is suitable etc. This should be set in motion with plenty of time for correspondence and time to accommodate any changes requested by the Technical Committee, or to purchase targets from another state, which has approved targets.
- b) ***If electronic Scoring targets are to be used, targets must be tested for accuracy prior to the competition according to ISSF procedures.*** This task is usually done by the Technical Delegate with assistance from the host state.

#### 6.3.2 Numbering

- a) For paper targets the method of numbering should have been decided in conjunction with the proposed statistical operations. It is advisable to have the targets numbered well in advance of the match. Labels are a successful solution and should be placed close to where the scores will be written e.g. bottom right corner.
- b) For a Three Position Match; targets should be marked to indicate Kneeling, Prone and Standing.

### 6.4 Backing Cards

- a) The backing cards must be numbered in conjunction with the targets and in exactly the same manner.
- b) These are only used for target cards where the frames allow for such.
- c) Where it is not possible to use Backing Cards, crossfire baffles would be of benefit to the shooters and the scorers.

### 6.5 Target Control - paper targets

- a) Consider whether the competitors are to change their own targets or whether range officials will change the targets.
- b) If officials are to change targets, then rosters should be drawn up to make sure that there is no undue delay.

### 6.6 Gauges

***Gauges and other measuring devices should be of a type approved by the Technical Committee and should have been checked by the Technical Delegate for accuracy. The TRA gauges are stored along with the state flags.***

## 7. RULES OF COMPETITION

### 7.1 Finals

*Finals will be held if range facilities allow and will be conducted as follows:*

<b>3 Positions (3 x 40)</b>	<b>Men's Final</b>	<b>(Men's Championship)</b>
	<b>Women's Final</b>	<b>(Women's Championship)</b>
<b>Air Rifle Men</b>	<b>Men's Final</b>	<b>(Men's Championship)</b>
<b>Air Rifle Women</b>	<b>Women's Final</b>	<b>(Women's Championship)</b>
<b>Air Rifle Championship</b>	<b>Open Final</b>	<b>(Open Championship)</b>

- a) *Finals will only be held if there are at least 5 competitors.*
- b) *Finals for all WSPS events will be conducted according to ISSF/WSPS (IPC) Rules.*
- c) *Finals in Shooting Australia Performance Series events will be conducted according to SA requirements.*

### 7.2 Scores/Results

*All score results must be produced in triplicate. i.e. One copy for posting, one copy for the Technical Delegate and one copy for association records. All results from all events should be posted on the Official Notice Board as soon as possible after the completion of each relay, as well as final results at the completion of each event.*

Posting of daily results on Websites and 'face book' is an excellent way of sharing news of the event.

- a) *TRA Open Results will be taken from Match scores unless otherwise specified. (see 7.1)*
- b) *All match results, match format & timings will be as per 9.4 Events Table.*
- c) *Where paper targets are used, all .22 results will be by integer scoring. ISSF & IPC/WSPS Air Rifle Results will be by decimal scoring utilising an appropriate electronic scoring machine.*
- d) *States may, upon request to TRA, conduct events at the Nationals as Shooting Australia Performance Series Events. Finals will then be conducted to ISSF standard and in accordance with SA requirements. This may be subject to changes made by Shooting Australia & the ISSF.*
- e) *Although most results now produced electronically, results should also be presented in a suitable format. Results produced by EST's (SIUS/Meyton) are suitable.*

### 7.3 Juniors

*Juniors to be under the age of 21 as at 31<sup>st</sup> December in the year of the competition (as per ISSF rules).*

### 7.4 Veterans

*Veterans to be over the age of 60 as at 31<sup>st</sup> December in the year of the competition.*

### 7.5 Grades

- a) *Entry into grades is optional.*
- b) *A fee of \$5.00 per competitor will be charged for entry into the graded matches.*
- c) *Grade medals will only be presented where there are 30 or more total entries in the graded event.*
- d) *Grade awards are based on match scores without finals.*
- e) *Grade awards will be given to the highest scoring competitors in each Grade (Master,A,B,C,D where applicable).*
- f) *Awards will be presented in accordance with 12.2.a.*
- g) *Where there is only 1 entry in a particular grade, this grade will be combined with the next higher grade.*
- h) *Where there is only 1 grade, grade awards will not be presented.*

- i) **Scores eligible for National Grading must be shot in competitions recognised by State associations.**
- j) **The following grading scales are TRA National Grades and will be used for the National Championships graded matches where applicable.**

## 7.6 Scoring Protests

## 7.7 Teams

- a) **There shall be State Team/Pairs events in the National Championships programme with the proviso that there shall be only one State representative team entered in any one State Team event and there must be two or more teams participating for any teams match to be conducted.**
- b) **Team members must be affiliated members of the State for which they are competing.**
- c) **International Team representatives may enter team events but will not be awarded State Team trophies. In the case of an International Team attaining the top score, acknowledgement of the achievement may be made by the presentation of certificates.**

## 8. MATCHES

### 8.1 Entries

- a) **Entry to all events, with the exception of team events and State Champion of Champions matches, is as an individual.** *i.e. From a particular state not representing a particular state.*
- b) **All entrants must be affiliated members of Target Rifle Australia Limited and their relevant State Association.**
- c) **Entries will also be accepted from shooters affiliated with International Smallbore Shooting Federations.** *E.g. Target Shooting New Zealand.*
- d) **The entry form (online & printable) will be available via the online portal on the TRA website. (www.tra.org.au) Entries may be made online, by email or post. See entry form for entry and payment options.**
- e) **Details for the entry form shall follow the programme.**
- f) **The closing date for entries will be 4 weeks prior to the event to allow enough time for squadding.**

- g) For ranges with limited capacity it is extremely important for competitors to enter early though it is desirable that entry numbers for any events should not be limited.*
- h) Late entries may be accepted if space permits and is subject to approval by the organising committee. A late fee will apply.*
- i) It is the responsibility of the entering competitor to ensure that they have completed the entry form correctly and included all relevant information, events, grades and categories they wish to enter.*
- j) Acknowledgement of receipt of entry should be forwarded to the competitor.*

## **8.2 Advice**

*States and their members should be advised by:*

- a) e-mag if available*
- b) TRA and State web sites and facebook pages.*
- c) Flyers and electronic distribution*

## **8.3 Squadding Information**

- a) The squadding details should be finalised as soon as possible prior to the event and should be available to competitors upon registration.*
- b) The allocation of firing point positions shall be by drawing of lots.*
- c) Squadding for Day 2 of the Jim Smith Match should be according to results from Day 1. i.e. Higher ranked shooters squadded together, lower ranked shooters squadded together. State Team members should be squadded together if possible.*
- d) Juniors may be squadded with open competitors and are eligible for Open awards unless specified.*

## **8.4 Programme**

- a) Only approved core events may be included in the official programme.*
- b) The competition programme, including any variations, shall be forwarded to TRA for approval at least twelve (12) months prior to the Championships.*

## **8.5 Additional Events**

- a) Host states may conduct extra events if time permits. These events will not be included in the official programme and must not take priority over core events. Awards, if any, for these events will be provided by the host state.*
- c) When including extra events, consideration must also be given to the workload of officials assisting at the Championships.*

## **8.6 WSPS Events**

- a) WSPS events (match & finals) will be conducted according to ISSF & WSPS Rules.*
- b) Matches may be scheduled in conjunction with able-bodied matches but WSPS shooters should not be expected to contest more than one (1) match per day.*

## 10. PROGRAMME

- b) *Approved Core Events, as listed in 9.1, are mandatory and may only be changed by approval of the TRA Board.*
- c) *Programme will depend on many factors including range facilities & capacity, EST's or paper targets etc.*
- d) *Finals will be conducted, where applicable, as stated in 'Rules of Competition/Finals'.*
- e) *It is preferred that the relevant events are conducted as SA Performance Series ranking events. In this case, finals will be conducted according to SA & ISSF requirements.*

***Results of all Postal matches must be forwarded to the TRA Executive Officer as soon as possible after the conclusion of the Championships.***

- b) Badges or certificates to be presented.

### 11.2 Chairman's International Teams Match

#### Chairman's International Teams Match

- a) Teams to have a minimum of 4 shooters and up to a maximum of two less than those competing from any visiting country. The visiting country with the smaller number of competitors sets the maximum number of competitors in the Teams.
- b) To be shot at the National Championship as an International Teams Match in conjunction with the Jim Smith 50 Metre Match – total 2 days.
- c) The Perpetual Shield to be held by Australia or New Zealand.
- d) Other Countries winning must leave the trophy in Australia.
- e) Certificates or badges to each Australian Team Member.

### 11.3 Wakefield Cup

#### Wakefield Cup Team

- a) Team of 10, to be shot at the National Championships in conjunction with the Jim Smith Match, as per Slazenger Team.
- b) Certificates or badges to each Australian Team Member.

## 12. AWARDS & PRESENTATIONS

### Opening of Championship

Official openings by a Government person or high-ranking official could be organised.

### 12.2 Awards & Medals

***Only Medals, Badges or Certificates & sponsored prizes will be presented according to the following:***

- a) ***1 to 3 competitors - gold only***  
***4 to 6 competitors - gold , silver***  
***7+ competitors - gold, silver, bronze***  
***Certificates will be presented to 4<sup>th</sup> to 8<sup>th</sup> place in all open events.***
- b) ***At the Australian National Championships only medals, certificates, perpetual trophies and donated prizes are to be presented.***
- c) ***Only awards, as specified in TRA Awards List, are to be presented.***
- d) ***Sponsored prizes are to be presented in conjunction with TRA awards.***
- e) ***No additional awards are to be made in addition to TRA listed awards with the exception of those for approved additional events.***
- f) ***Overseas visiting competitors shall be eligible for the medals, certificates and titles only as individuals. Perpetual trophies must remain in Australia.***

***See Attachment C: Awards List***

### 12.3 Daily Award Presentation

- a) ***A designated, area should be set aside for all award ceremonies. A dais and suitable backdrop in a well-lit area should be made available.***
- b) ***The medal presentation is to be carried out at the earliest convenient time each day, where a Match has been finalised. Medals are to be presented on the dais with due pomp and ceremony appropriate for a National Championship Event. The competitors have worked hard to achieve their place on the podium. This is a special moment for them and they should be rewarded in an appropriate manner.***

- c) The person elected to MC/conduct the presentations should have knowledge of the correct procedure for the conduct of an award ceremony.
- d) It is beneficial and makes for a quicker ceremony if medal recipients are assembled before the presentations, in an area close to the dais. This saves time 'searching' for recipients or waiting for them to proceed to the dais through a crowd.
- e) Guest presenters, such as local politicians, could be invited to attend the award ceremonies. TRA Directors, State Association officials, local club officials, hard working volunteers & international shooters past & present could also be invited to present awards.
- f) Medal/awards recipients should also have some knowledge of the appropriate procedure when receiving an award. This may simply involve a short chat from a state captain or coach. While it is a proud moment for the recipients to be called to the podium, it can also be a little unnerving for some, especially newcomers and youngsters. Recipients should stand on the dais with pride, straight & tall - not casually on one leg with hands hanging in their pockets or arms crossed in front of their chests.
- g) Medallists should be appropriately dressed in a club, state or National team shirt or tracksuit, long shorts or track pants, covered shoes and **NO** caps or hats.

A suggested awards ceremony could be as follows:

*MC/Announcer:* **Ladies & Gentlemen, welcome to the Target Rifle Australia National Championships medal ceremony for the following events.**

*(The announcer should acknowledge all sponsors for the competition)*

**The medals will be presented today by (Mr. Joe Blogs - Local Council Representative)**

*(The guest speaker may wish to make a short speech so allow time & opportunity for this)*

*MC/Announcer:* **The first presentation today is for the Women's Air Rifle Event. In third place, representing the Northern Territory is Mary Smith.**

*(The recipient will then proceed to the 3<sup>rd</sup> position on the dais - medal will be placed around his/her neck by presenter - hand shake etc. This process will then be repeated for the second & first places. When 2<sup>nd</sup> & 1<sup>st</sup> placegetters are announced, they should proceed around the front of the dais, shake hands with the other medallists and proceed to the dais **from the back**. Allow a short time for photo opportunities.)*

At the conclusion of the presentations the announcer should thank the guest presenter/s

The task of the daily medal presentations can be made easier if daily award presentation sheets are prepared. This is also of benefit at the Presentation Dinner where there are multiple presentations. These blank forms can be prepared well in advance of the competition and simply completed when results are available.

#### **12.4 Presentation Dinner (if held)**

- a) A suitable location for the presentation dinner should be found allowing ample room for the presentation of trophies.
- b) Perpetual Trophies to be on display and presented along with any sponsorship trophies received, including both individual and/or Teams.
- c) Official attendance by a Government person or high-ranking official could be organised.

## 12.5 Perpetual Trophies & State Flags

- a) *It is the responsibility of the previous year's recipients to maintain and return the trophies to the next Championship.*
- b) *Any un-presented trophies, a list of trophy holders and the state flags must be sent to the state hosting the next National Championships.*
- c) The TRA Technical Committee should pursue this matter to remind the recipients to return these.
- d) Other perpetual trophies won throughout the year are also to be presented at this time. e.g. Grahame Lawler, Warren Potent, 3P Postal, BSA Shield etc.

## 12.6 Champion of State Champions

*The following Awards will be presented:*

*The Champion of State Champions badges for 10m Air Rifle and 50 Metre Prone shall be a special badge that is distinctive in style from the standard badges. These badges will be presented along with appropriate perpetual trophies.*

(At the time of publication, badges are donated by Mr. Reg McCreedy, Victoria)

- a) *Only current State Champions i.e. 50m State Champion & 10m Air Rifle State Champion, are eligible to be entered in the respective Champion of State Champions matches.*
- b) *Shooters must be a current affiliated member of the state for which they are nominated.*
- c) *At the time the relevant State Championship is contested/won, the winner must be an affiliated member of the state where the championship was held.*  
*For example: A shooter from Victoria may win the South Australian 50m match at the South Australian State Championships but he/she cannot be declared the SA resident State Champion as he/she is not affiliated with South Australia. He/she is not eligible to compete for SA in the Champion of State Champions event at the Nationals as he/she is not a South Australian affiliate and was not a SA affiliate at the time of the State Championship event.*
- d) *The 10m Champion of State Champions match will be held in conjunction with the Open Air Rifle Match.*
- e) *The 50m Champion of State Champions match will be held in conjunction with Day 1 of the Jim Smith Match.*
- f) *There must be at least 2 entries in an event otherwise the event will be abandoned and no awards will be presented. See 12.2.a*

## 13. RESULTS BOOK

- a) *Collation of results should be done on a daily basis.*
- b) *Event results should be posted on the host state and/or TRA websites as soon as practical, preferably at the end of each day's competition.*
- c) *A complete Results Book should be sent to each State Secretary, the TRA Technical Committee and TRA Competitions Committee by disc, USB or email as soon as possible after the Nationals.*
- d) *Only results of matches and categories where awards have been presented are to be included in the results book. e.g. List of Veterans in an event if there are no awards presented for the Veterans category in that event.*
- e) *Results from addition events conducted by the host state may be included at the end of the Results Book as a matter of interest.*
- f) *The Results Book should contain lists of:*
  - 1. *Contents*
  - 2. *Perpetual Trophy/Match Winners*
  - 3. *Records Broken/Equalled*
  - 4. *All match results in accordance with the programme*
  - 5. *Full result list of Position & Prone Championships*
  - 6. *Postal Competition Results*

## 14. AUSTRALIAN RECORDS

The recording of Australian Records is the responsibility of the Technical Committee in consultation with the appointed TRA Records Statistician.

*It is the responsibility of the National Championship Technical delegate to forward any record scores to the TRA Records Statistician.*

*Claims for Verification of Record Score*

- a) *For claiming a record score at the National Championships, the Technical Delegate is to ensure that the Classification Jury has rechecked all targets/printouts relating to the record score.*
- b) *Targets/printer ribbons/individual result printouts are to be retained by the Host State for a period of six (6) months.*
- c) *One "Claim for Verification of TRA Record Score" form is required to accompany a complete list of scores for the event(s) and is to be forwarded to the Records Statistician.*

## Attachment B:

### SLAZENGER CHALLENGE SHIELD - TEAMS MATCH AUSTRALIA V NEW ZEALAND RULES AND CONDITIONS

1. Teams of twenty to be selected by the respective National Associations of Australia and New Zealand with the match shot as part of each National Association's Outdoor National Championships annually.
2. The designated match shall be 1 x 50m Prone Rifle Match (60 scoring shots) as recognised by the ISSF
3. The use of either the decimal or the integer scoring system shall be determined by mutual agreement between the two National Associations annually.
4. Match Format and Time Limits:
  - a. Where the course of fire is completed on Electronic Targets or Target Changing Machines, then ISSF 7.7.4 applies.
  - b. Where the course of fire is completed on Multi-Diagram or Multi-Card systems then the time limits shall be those as stated in the respective country's rules:
    - i. For Australia - TRA Ltd Supplementary Rule A.6.3.1
    - ii. For New Zealand – Rules of Conduct Outdoor Competition Rule 3.6.2
5. ISSF Rules for equipment and match conditions should be complied with as closely as practicable, however the following specific exceptions apply:
  - a. The ISSF clothing regulations shall not be rigidly enforced provided the competitor gains no unfair advantage.
  - b. No magnifying combination of lenses is permitted except that one lens not exceeding 0.5 diopter (1.5 magnification) may be fitted to either the front or the rear sight in addition to a sight-correction lens which may be worn by the shooter or attached to the rear sight.
  - c. Butt-stocks may extend beyond 140mm from the centreline of the bore.
  - d. Personal shooting mats may be used as per TRA Supplementary Rules or TSNZ Outdoor Competition Rules.
6. Athletes with a disability, who are able to comply with World Shooting Para Sport (WSPS) under Category SH1, are eligible to take part in this competition.
7. Cards (or records of results) to be scored and verified by the respective National Associations and the results forwarded to the opposing National Association as soon as practically possible following the conclusion of the respective National Championships. Shot targets (or records of results) should be kept until the publication of results.
8. The winning National Association to be the holders of the Slazenger Challenge Shield with each team member and captain receiving a badge or certificate.

#### **Australian Team Selection Conditions:**

- a) Australian Team of 20 plus 2 emergencies, to be shot in conjunction with the ISSF 50m Prone Championship Matches held during the Australian National Championships.
- b) Team members selected shall be the top 20 shooters plus 2 emergencies.

#### **New Zealand Team Selection Conditions:**

- a) NZ Team of 20 plus 2 emergencies, to be shot as an International Match which may be shot in conjunction with other International Matches held during the NZ Outdoor National Championships.
- b) Team members selected shall be the top 22 shooters from an Aggregate of Graded 1 Match plus Graded 2 match (if held) plus National Championship Match (i.e. the Elimination Match if held, or the Selection Match if no Elimination Match required), with the 2 lowest ranked shooters to be named as Emergencies.
- c) Each Team member's results from the International Match shall be used for the Slazenger Challenge Shield Teams Match.
